<p>Shall the Board of Trustees of K-12 School District No. 28 (St. Ignatius), Lake County, Montana (the "District"), be authorized to sell and issue general obligation bonds of the District in one or more series in the aggregate principal amount of up to Five Million Two Hundred Thousand and No/100 Dollars (\$5,200,000.00), bearing interest at rates to be determined at the time of the sale, payable semiannually, during a term as to each series of bonds of not more than twenty (20) years, for the purpose of providing funds to pay the costs of designing, constructing, equipping, and furnishing improvements to school buildings on the St. Ignatius Public Schools campus, including building additions to the middle and high school to include a new gymnasium, weight room, locker rooms, restrooms, and shop and technology space; remodeling or repairing the current gymnasium, lockers, and tennis courts; reroofing a portion of the elementary school building; replacing furnishings and fixtures and implementing associated deferred maintenance projects; related improvements; and paying costs associated with the sale and issuance of the bonds?</p>
